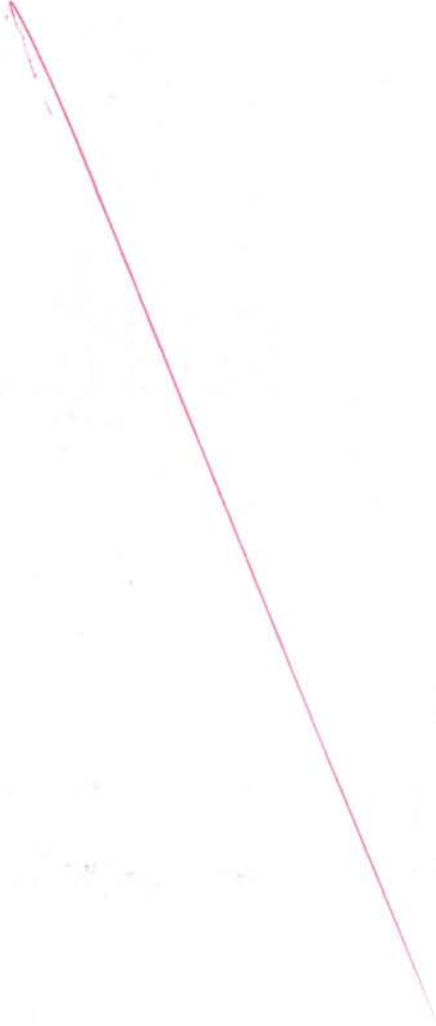

Agenda Item No.1 : Confirmation of previous meeting minutes.


Resolution : **Resolved** that the minutes of the previous General Body meeting of the Society held at its registered office as read out by the Secretary, are confirmed.
