MEMORANDUM OF UNDERSTANDING (MoU)

This Memorandum of Understanding (MoU) is made and entered into on this [13] Day

of [12] Month, [2025] Year, by and between:

PKN Life Sciences Private Limited, having its registered office at [Address], hereinafter referred to as "**PKN Life Sciences Private Limited**", which expression shall, unless repugnant to the context or meaning thereof, include its successors and permitted assigns.

AND

Narayana Medical College, a premier institution under the Narayana Educational Society, located at [Address], herein referred to as "**NMC**", which expression shall, unless repugnant to the context or meaning thereof, include its successors and permitted assigns.

1. Purpose

The purpose of this MoU is to establish a collaborative framework between **PKN Life Sciences Private Limited** and **NMC** to:

- Promote joint **research and development (R&D)** in the area of Nutraceutical, Herbal and Nano based drug formulations.
- Facilitate **academic and industry collaboration**.
- Share knowledge, infrastructure, and expertise for product innovation and clinical development.

2. Scope of Collaboration

The collaboration shall include but not be limited to:

- Joint R&D projects on nano-formulations.
- Sharing of laboratory and testing facilities.
- Exchange of research personnel, scientists, and students.
- Conducting preclinical and clinical evaluations.
- Intellectual property (IP) generation and technology transfer.
- Publication of joint research findings (subject to mutual consent).

3. Roles and Responsibilities

PKN Life Sciences Private Limited shall:

- Provide materials for agreed R&D projects.
- Share its expertise in pharmaceutical formulation and regulatory affairs.
- Support product development and commercialization efforts.

Narayana Medical College shall:

- Provide research facilities, including laboratories and qualified personnel.
- Facilitate preclinical Studies and clinical trials.
- Ensure academic and technical guidance through its research faculty.

4. Confidentiality

Both parties agree to maintain strict confidentiality of all information shared under this MoU and shall not disclose such information to any third party without prior written consent.

5. Intellectual Property Rights

Ownership and rights to any intellectual property developed through this collaboration shall be jointly held, unless otherwise mutually agreed upon in writing. Specific IP terms will be detailed in separate project agreements.

6. Duration and Termination

- This MoU shall be effective from the date of signing and shall remain in force for **Five (5) years**, unless terminated earlier by either party with a **90-day written notice**.
- The MoU may be renewed or extended upon mutual agreement.

7. Dispute Resolution

In the event of any dispute arising out of or in connection with this MoU, both parties shall attempt to resolve it amicably. If unresolved, it shall be referred to arbitration under Indian Arbitration and Conciliation Act, 1996.

8. Legal and Binding Agreement

This MoU represents the mutual understanding of the parties and does not constitute a legally binding contract. However, it expresses a serious intention to collaborate in good faith.
