Structure and Mechanism for Internal Quality Assurance (IQAC)

1. Introduction

The Internal Quality Assurance Cell (IQAC) of Narayana Medical College serves as a nodal agency for planning, guiding, and monitoring quality assurance and enhancement activities of the institution. It ensures continuous improvement in the academic, administrative, and clinical services of the college and hospital.

The IQAC functions in accordance with NAAC guidelines and the recommendations of the National Medical Commission (NMC) on quality assurance and institutional governance.

2. Objectives

- To develop a system for conscious, consistent, and catalytic improvement in the performance of the institution.
- To promote measures for institutional functioning towards quality enhancement through internalization of quality culture.
- To integrate modern teaching-learning and evaluation practices into institutional functioning.
- To ensure accountability and transparency in all academic, research, and administrative processes.

3. Structure of IQAC

The IQAC of Narayana Medical College comprises the following members:

4. Organizational Hierarchy

Governing Body → Principal → IQAC → Departmental Quality Circles → Faculty / Staff / Students

Each department has a Departmental Quality Nodal Officer (DQNO) who coordinates with IQAC for data collection, implementation of quality initiatives, and reporting outcomes.

6. Quality Assurance Process Flow

Step 1: Collection of feedback/data from stakeholders → Step 2: Review by IQAC → Step 3: Action plan and dissemination to departments → Step 4: Implementation by concerned committees → Step 5: Monitoring and evaluation by IQAC → Step 6: Documentation and reporting to Principal & Governing Council.

7. Documentation and Reporting

IQAC maintains records of all meetings, decisions, and quality initiatives. Annual Quality Assurance Report (AQAR) is prepared and submitted to NAAC. Progress reports are presented before the College Council and Management for review and approval. Key activities are uploaded on the institutional website for transparency.

8. Review and Evaluation

IQAC conducts quarterly meetings to review the implementation of the annual quality plan. Annual Internal Academic and Administrative Audits (AAA) are conducted. Outcomes are used to frame policies and reforms for the next academic year.
