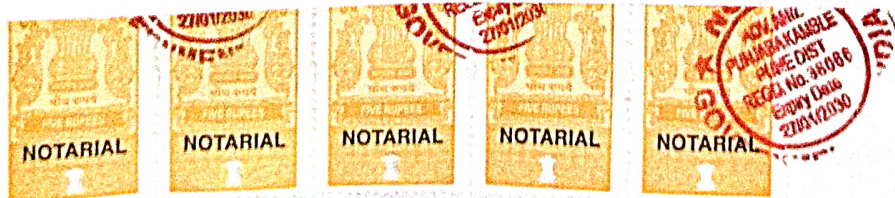
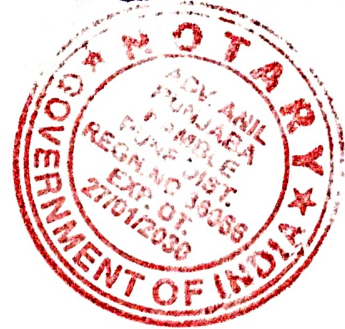

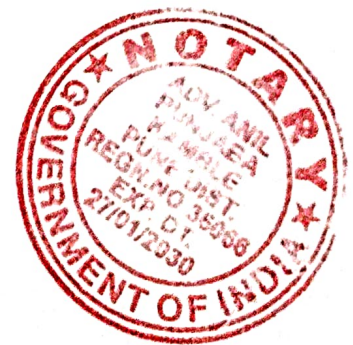
AFFIDAVIT

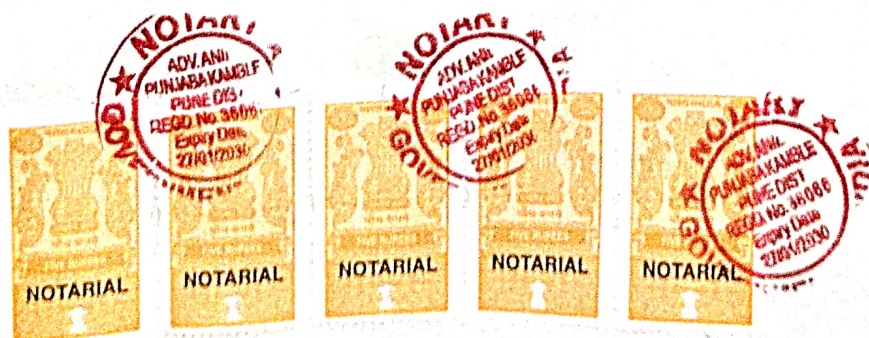
- 1 That Narayana Educational Society, registered under Societies Registration Act 2001.

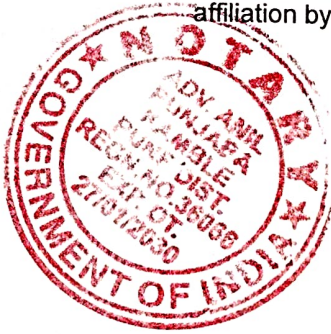

APPENDIX-IV

- 12 That the school will follow the provisions related to fee contained in affiliation byelaws and will disclose the details of the fee to the students/parents every year before start of session without resorting to any hidden charges in the heads of the fee.
