



 1. No structures with inflammable roof must be allowed within the premises.
 2. If repairs and renovations are not done once in 6 months, this certificate will automatically be cancelled.
 3. This certificate covers the above mentioned buildings only and does not include any other structure or buildings within the premises for other purposes.
 4. This certificate does not include the eventualities cause by natural calamities, like high gale, earthquake, heavy rain, cyclone, storm, lightening, floods, fire, etc.
 5. If this certificate is tampered with illegally/unauthorized without the knowledge, permission and signature of the undersigned, this certificate will automatically be getting cancelled.
 6. This certificate is not conclude to any title dispute in respect of the property/building.
 7. The owner is instructed to check the roof materials, columns etc., now and then and if any material is damaged the same shall be replaced immediately, if not this certificate will automatically be getting cancelled. Unused buildings must be removed.
 8. The owner is instructed to stop the classes during heavy gale, rain or wind as the structure will withstand only normal velocity of wind, if not this certificate will automatically be getting cancelled. Open terrace, Corridor and staircase must be barred.
 9. If additions or alterations shall be made without the prior permission and signature of the undersigned this certificate will automatically be getting cancelled.
 10. This certificate has been issued only on physical inspection of the premises. No approved plan for the building has been produced. Only the floor plan has been produced for my perusal.
