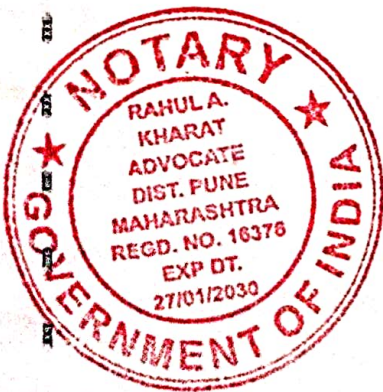

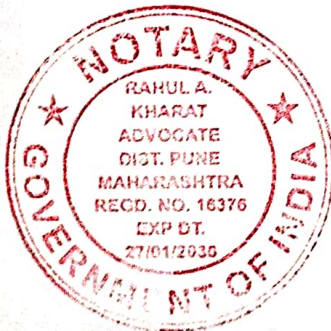

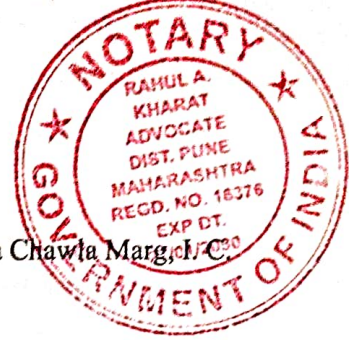

Subject - Letter of Intent to start a new school or upgrade the status of existing schools on self-financed basis under the Maharashtra Self-Financed Schools (Establishment and Regulation) Act, 2012...

Narayana Education Trust, Mumbai run Narayana E-Techno School, Undri, Tal. Haveli, Dist. Pune Survey No. 40/1/1/2/40/1/2 to 6/Plot No./52, Village Undri, Tal. Haveli, Dist. Pune.

Under the Maharashtra Self-Aided Schools (Establishment and Regulation) Act, 2012, Narayana Education Trust, Mumbai has submitted an application for starting a new school on self-aided basis, Narayana E-Techno School, Undri, Tal. Haveli, Dist. Pune, Survey No. 40/1/1/2/40/1/2 to 6/Plot No./52, Village Undri, Tal. Haveli, Dist. Pune (Primary to Higher Secondary, 1st to 12th, English Medium, C.B.S.E.).

2. With reference to your application on the above subject, you are hereby informed that under the Maharashtra Self-Aided Schools (Establishment and Regulation) Act, 2012 and the Maharashtra Self-Aided Schools (Establishment and Regulation) Rules, 2020, a letter of intent is being issued to start a new school on self-aided basis (Primary to Higher Secondary, 1st to 12th, English Medium, CBSE) with the following terms and conditions, from the academic year 2024-25, Narayana Education Trust, Mumbai, a State Board affiliated school, Narayana E-Techno School, Undri, Tal. Haveli, Dist. Pune, Survey No. 40/1/1/2/40/1/2 to 6/Plot No./52, Mauje Undri, Tal. Haveli, Dist. Pune.

3. Terms and Conditions:-

(One) The said letter of intent does not guarantee the issuance of a letter of approval without compliance with the provisions of the Act and the rules made thereunder.

(Two) Based on the said letter of intent, the registered institution or trust or company will not be able to start a school/up gradation class. (3) The said letter of intent cannot be used as a no-objection certificate for affiliation to CBSE/ ICSE/ IGCSE/ IV, etc. boards.

(Three) The said letter of intent cannot be used as a no-objection certificate for affiliation to boards like CVSE/ ICSE/ IGCSE/ IV, etc.

(Four) It shall be mandatory for the registered institution or trust or company to comply with the standards, terms and conditions of the infrastructure and physical facilities (such as classrooms, toilets, drinking water facilities, principal and staff quarters, library, laboratory, etc.) as prescribed in the Right of Children to Free and Compulsory Education Act, 2009 and the Maharashtra Right of Children to Free and Compulsory Education Rules, 2011 and the directions issued by the Government from time to time through the Acts and Rules.

(Five) After complying with the above facilities, it shall be the responsibility of the institution or trust or company to submit an application for recognition to the Area Level Authority of the concerned district within 18 months from the date of receipt of the letter of intent.

(Six) If the school management fails to submit an application for recognition within 18 months, the letter of intent shall stand cancelled. The period of the letter of intent shall not be extended under any circumstances.

(Seven) After the issue of the letter of intent, the location of the proposed school shall not be changed. If the management has applied for recognition at a location other than that approved by the Government, the letter of intent shall stand cancelled.

(Eight) The State Government may, at any time, cancel the letter of intent granted on the ground of violation of any of the provisions of this Act or the rules made thereunder or failure to comply with any directions given under the Act or any standards or norms specified by the Government from time to time or any terms and conditions.

(Nine) The said institution or trust or company shall be required to keep the amount specified in "Schedule C" of the Act jointly in the name of the management and the concerned Education Officer (Secondary), in the form of National Savings Certificate or in the form of fixed deposit in any nationalized bank.

(Ten) It shall be mandatory to strictly implement the guidelines given in the context of student safety under the Government Circular dated 02nd June, 2018 and the measures regarding the safety of students under the Government Decision dated 21st August, 2024.
