Recommendations On Statute On Affiliation Of Colleges Of B.Sc. Paramedical Courses
Adopted By The Executive Council Of Dr. NTR University Of Health Sciences.

In exercise of the powers conferred by sub-section (2) section 31 of the University of Health Sciences Act, 1986 (Act No.6 of 1986), the Executive Council of the University of Health Sciences, Vijayawada hereby makes the following statutes:-

1. i) These statutes may be called the Statutes for Affiliation of Colleges of B.Sc. Paramedical Courses (a. Anesthesia Technology & Operation Theatre Technology, b. Cardiovascular Care Technology & Cardio Vascular Technology, c. Renal Dialysis Technology, d. Medical Imaging Technology, e. Neurophysiology Technology, f. Perfusion Technology g. Emergency Medical Technology h. Respiratory Therapy Technology) – hereinafter called B.Sc. Paramedical Courses) to Dr. NTR University of Health Sciences.
ii) They shall come into force from the date of assent of the Chancellor.
2. The words and phrases used in these statutes shall, unless expressly explained otherwise, have the same meaning as they have with reference to the Dr. NTR University of Health Sciences Act 1986 (UHS Act 6 of 1986) hereinafter called the Act.
3. It shall be necessary for the proposed College of B.Sc. Paramedical Courses, (a. Anesthesia Technology & Operation Theatre Technology, b. Cardiovascular Care Technology & Cardio Vascular Technology, c. Renal Dialysis Technology, d. Medical Imaging Technology, e. Neurophysiology Technology, f. Perfusion Technology g. Emergency Medical Technology h. Respiratory Therapy Technology) seeking affiliation to the Dr. NTR University of Health Sciences, Vijayawada for starting 1st year Bachelor of Science in these courses of study to apply for Certificate of Registration / affiliation of their institution with Dr. NTR University of Health Sciences, Vijayawada.
4. (i) Government medical colleges and Private Medical Colleges affiliated to Dr.NTR UHS. Vijayawada which satisfies the conditions stipulated hereunder in sub-statute shall be eligible for starting B.Sc. Paramedical Courses mentioned above. Application from the individuals for Certificate of Registration and affiliation will not be entertained. Other institutions may be permitted after four years of commencing these courses – i.e., one year after the first batch of students of these B.Sc. Courses is released.
(ii) Conditions to be satisfied by the applicant for applying for Certificate of Registration and affiliation for these B.Sc. Paramedical Courses.
 - a) The institution must be a Modern Medical College having an attached teaching Hospital with recognized MBBS courses and recognized PG courses in the said subjects i.e., a. Anesthesia Technology & Operation Theatre Technology, b. Cardiovascular Care Technology & Cardio Vascular Technology, c. Renal Dialysis Technology, d. Medical Imaging Technology, e. Neurophysiology Technology, f. Perfusion Technology g. Emergency Medical Technology h. Respiratory Therapy Technology respectively. The teaching hospital shall have the diagnostic facilities in above departments and in Biochemistry, Clinical Pathology and Microbiology. These departments should be headed by qualified teaching staff as prescribed by the Medical Council of India. The hospital should have facility of blood bank as per the concerned regulations.
 - b) The Hospital / College shall have the following full-fledged departments under qualified teaching staff as specified by the Medical Council of India with the following sections:

Parent Department:

All departments must have 20 bedded ward, 5 beds ICU, with following specific equipments.

1. Cardiology (B.Sc. Cardiac Care Technology & Cardio Vascular Technology):

- a) ECG, Echo, TEE, Treadmill, Cathlab, Holter, 10 beds ICU with all modern monitoring equipment, defibrillators.

2. Cardio Thoracic Surgery (1. B.Sc. Perfusion Technology) (2. Cardio Thoracic Physician Assistant Course):

- a) Operation Theater 1 or 2 with all open-heart surgery equipment.
- b) CTICU – 6bedded with all monitoring equipment defibrillators bed x-ray, ECG, Echo, IABP, ABG etc.,

3. Neurology (B.Sc. Neuro Physiology Technology):

- a) EEG Machine Analogue – 1
- b) EEG Machine Digital – 1
- c) EMG/NCS/EP Machine – 2
- d) Video EEG – 1

4. Nephrology (B.Sc. Renal Dialysis Technology):

- a) Hemodialysis department with 10 HD machines
- b) Peritoneal dialysis facility
- c) Renal Lab with kidney biopsy facility.

5. Anaesthesia Department (B.Sc. Anaesthesia Technology & Operation Theatre Technology):

- a) Minimum 4 Operation theaters (2-General & 2-Speciality)
- b) PACU with 6 beds (Recovery room)
- c) RICU with 6 beds
- d) Work station – 4, ABG, Monitors, defibrillators, Crash Carts, ICU ventilators -6, Central Oxygen and Suction.
- e) CSSD.

6. Radiology Department (B.Sc. Imaging Technology):

- a) X-ray machine: 300 ma -5
- b) Digital X-Ray machines with printer -2
- c) Ultra sound machine with all probes and colour Doppler – 2
- d) CT scan machine – 64 slices – 1
- e) MRI Machine 0.3/1.5 tesla – 1
- f) Mammography machine – 1
- g) Fluoroscopy machine – 1

7. Ophthalmology Department (B.Sc. Optometry Technology):

- a) Thin lenses, Thick Lenses, Prisms with all diopters and refractory equipment.
- b) Optical & ophthalmic instruments: Standard Test Charts, Retinoscopes, Ophthalmoscopes (direct & indirect), Refractometers, Auto Refractometers, Slit lamps, Keratometer, tonometer, devices for colour vision testing, ultra sonogram (A scan & B Scan)

8. B.Sc.(Emergency Medical Technology)

ECG, 2DEcho, TMT, X-Ray Machine, Ventilators, multipara, monitors defibrillators, pulse Oxymeter, USG mammo, ABG, Electrolytes, Creatin, central lines, Incubation sets, holters, 10 beds each ICU, INCU, AMC, RICU, Ophthalmoscopes, Nebulizer, C-PAP, Apparatus, all blood investigations, Refrigerators, Tutorial Rooms, Staff Room. Dress Changing Rooms, with Room Facilities, Difficult intubation Carts, Crash Carts, CT Scan, MRI Scan, C-Arm.

9. B.Sc.(Respiratory Therapy Technology)

ECG, 2DEcho, TMT, X-Ray Machine, Ventilators, multipara, monitors defibrillators, pulse Oxymeter, USG mammo, ABG machines, Electrolytes, Creatine, central lines, Incubation sets, holters, 10 beds each ICU, INCU, AMC, RICU, Ophthalmoscopes, Nebulizer, C-PAP, Apparatus, all blood investigations, Refrigerators, Tutorial Rooms, Staff Room. Dress Changing Rooms, with Room Facilities, Difficult intubation Carts, Crash Carts.

- j) Room for staff, tutorial room, waiting hall for patients with facility for blood collection.

5. Pharmacology Department as per MCI Guidelines of 100 MBBS seats intake.

6. Radiology department fully equipped with:

- a) X-ray machines
- b) digital x-ray machines
- c) ultrasound machines
- d) CT scan machine
- e) MRI machine
- f) Mammography machine
- g) C-arm

7. Cardiology department with

- a) ECG machines
- b) Echocardiography machines
- c) Treadmill
- d) ICCU

8. Anesthesia department as per MCI Guidelines of 100 MBBS seats intake.

9. Surgery department as per MCI Guidelines of 100 MBBS seats intake.

10. Medicine as per MCI Guidelines of 100 MBBS seats intake.

5. The application for Certificate of Registration and affiliation from the Dr. NTR University of Health Sciences, Vijayawada shall be in writing and in **Form-I annexed** with these statutes addressed to the Registrar of the Dr. NTR University of Health Sciences, Vijayawada and shall be submitted to the Registrar before 1st July of the Academic Year preceding to which affiliation is sought for. The inspection fee of Rs.25,000/- for each course is waived off for government medical colleges.
6. The application for Certificate of Registration and affiliation shall be submitted along with the Essentiality Certificate/ Govt. order issued by the Government of Andhra Pradesh to establish the course and shall contain the following particulars namely.
 - a) Name of the owner – Government / Trust / Society with full address;
 - b) Name of the proposed College if any
 - c) Place and address where the Courses are to be located with telephone number, if available;
 - d) The number of students proposed to be admitted in the first year of the course – this may be limited to ten per course for now.
 - e) The availability of the Land, Building and other physical infrastructure, training facility available to the students to be admitted;
 - f) Ready built-in area available for accommodation of the academic complex;
 - g) Residential quarters for the staff of the college;
 - h) Playground;
 - i) Hostels if available for boys and girls;
 - j) The applicant shall provide such other particulars as may be required by the University of Health Sciences, Vijayawada, from time to time.

7. On receipt of the application for the Certificate of Registration and affiliation the University shall scrutinize the same and verify by deputing an Inspection Commission whether the conditions required to be fulfilled by the applicant to become eligible to receive the said certificate of Registration and affiliation are fulfilled. The Inspection Commission will consist of eminent persons in the faculty, preferably from government institutions but not from the same college which is applying for the said course.
8. The Inspection Commission shall specifically examine whether the following conditions are fulfilled by the applicant. The proforma of Inspection Commission report to be furnished by the Inspectors shall be in **Form-III Annexed** with these statutes.

Conditions to be fulfilled by the applicant to become eligible to receive the Certificate of Registration and affiliation.

- a) The applicant shall satisfy the University that all the infrastructural facilities of the college are in one campus.
 - b) The college should have in addition a workshop for Medical instrumentation.
 - c) The applicant shall own a ready built area of 15,000 sq.ft. suitable for starting the B.Sc. Paramedical Courses with proper sanitation facilities, provision for safe drinking water, adequate water supply for clinical and laboratory purposes, library, store rooms, toilets for students, staff (separately for men and women) hostels (separately for boys and girls) and such other facilities necessary and those that may be specified by the University from time to time in this regard.
9. The applicant shall before applying for Registration and affiliation for the 1st year B.Sc. Paramedical Courses of study, fulfil the following conditions, namely:-
 - a) shall have obtained Essentiality Certificate from the Government of Andhra Pradesh.
 - b) Shall appoint or contract to appoint Principal and Professor who shall be a qualified teacher in the said course
 - c) shall submit letters for appointment of qualified staff members as detailed below, which are absolutely essential to become eligible to start the first year B.Sc. Courses of study in the said subject

QUALIFICATIONS OF STAFF:**i) Director & Programme Coordinator:**

The Director and Programme Coordinator should preferably be a Professor and have MD / MS Degree with 8 years teaching experience. The Principal of the Medical College will be the Director Cum Programme Coordinator.

ii) Professor:

MD / MS Degree in the said subject with at least 8 years teaching experience.

iii) For the post of Assistant Professors:

MD Degree in the concerned Specialty.

iv) Lecturer in English:

M.A. in English securing minimum 55% marks and preferably at least one year teaching experience.

v) Librarian:

Degree in Bachelor of Library and information science securing 55% of marks.

- d) The applicant shall produce evidence to the effect that the proposed college of B.Sc. Paramedical Courses is fully equipped in the following aspects:

10. In case there are lacunae in the fulfillment of the conditions, the same may be informed to the consent management after receiving of the compliance report of the management, the University may conduct reinsertion on payment of a sum of Rs. 10,000/- (Rupees ten thousand only) or such amount as may be prescribed by the Executive Council from time to time, by means of a Demand Draft drawn in favour of the Registrar, Dr. NTR University of Health Sciences, Vijayawada towards the re-inspection fee and shall receive a final report from the Inspection Commission. (The fee may be waived off for government medical colleges).

11. When the University is fully satisfied on the basis of the Inspection report that all the conditions required to be fulfilled by the applicant are fulfilled, it shall issue a Certificate of Registration and Provisional Affiliation to the applicant to enable the applicant to start the first year B.Sc. Courses in the said subject mentioned above and for which affiliation is granted by the Dr NTRUHS. The payment of affiliation fee of Rs.2.00 lakhs in the name of the Registrar or as fixed by the Executive Council of University and fulfillment of other provisions in this statute is waived off for government medical colleges.
12. The University shall be competent to withdraw the provisional affiliation granted herein by giving three months' notice stating the reasons thereof to the applicant.
13. (1) The provisional affiliation granted by the University shall be only for the first year B.Sc. Paramedical Courses of study.

(2) The college shall have a duly constituted Governing Body / Managing Committee with the representatives of the teaching staff, to advise the Principal in the internal affairs of the college. The Committee shall have at least one representatives of the University nominated by the Vice-Chancellor and one representative of the Government of AP from the Medical Education Department nominated by the Government. A record of the proceedings of the said Governing Body / Managing Committee shall be maintained by the Principal who shall be the Secretary to the Governing Body / Managing Committee.

The Governing Body shall have as its members not less than 6 and not more than 10 members including

- a) Director and Programme Coordinator / Principal
- b) One persons nominated by the Vice-Chancellor to represent the University.
- c) Vice Principal (Academic)
- d) One person from each subject of the teaching staff of the College concerned by election from among themselves, of which at least half are from the subjects of the B.Sc. courses and at least one is from the Medical Education Unit.

(3) The member nominated by the University under sub-statute (2) shall hold office for a period of two years. Any change in the Governing Body of the college shall be reported to the University immediately.

(5) The Governing Body / Managing Committee of the college shall meet at least once in three months to consider the budget estimates and such other matters as may arise in its working. It shall meet in May-June each year to consider the Annual Report, the audited statement of accounts, changes in the staff, subjects or courses in which fresh affiliation or approval is to be sought in the following year. A copy of the notice of meeting shall be sent to the nominee of the University, with a copy to the Registrar at least 15 clear days before the date of the meeting. A copy of minutes of the meeting shall also be sent to the nominee of the University and the Registrar within fifteen days of the meeting.

(6) The college shall periodically submit to Dr.NTRUHS and update the list of faculty members in the college in the said departments and related departments to Dr.NTRUHS.

14. By the time six months period is left for the first year B.Sc. Paramedical Courses Exam, the applicant shall apply to the University for affiliation of the second year B.Sc. Paramedical Courses in **Form – II Annexed** with these statutes. Before applying so, the following facilities and departments with the staff members stipulated herein have to be provided in the college of B.Sc. Paramedical Courses, and the details there of shall be furnished in the said application. The payment of a Demand Draft for Rs. 25,000/- (Rupees twenty five thousand only) or such amount as may be prescribed by the Executive Council from time to time may be waived off for government medical colleges.
15. On receipt of the application for affiliation for the second year B.Sc. Paramedical Course of study the University shall send its Inspection Commission at least three months before the date of commencement of the first year B.Sc. Paramedical Course examinations.

16. The Inspection Commission sent by the University shall inspect the facilities available in the college and report to the University as to whether all the facilities required to be provided by the college are actually provided. The Inspection Commission shall also point out in its report the lacunae, if any, in the fulfillment of the conditions, required to be fulfilled and also advise as to the capability of the college to rectify the lacunae within a period of two months. In case there are lacunae in the fulfillment of the conditions the University may conduct re-inspection on payment by the applicant of a sum of Rs.25,000/- (Rupees twenty five thousand only) or such amount as may be prescribed by the Executive Council from time to time by means of a demand draft drawn in favour of the Registrar, Dr. NTR University of Health Sciences, Vijayawada towards the re-inspection fee and shall receive a final report from the Inspection Commission.
17. After a detailed examination of the final report of the Inspection Commission, if the University is fully satisfied as to the fulfillment of the conditions for the affiliation for the second year B.Sc. Paramedical Course of study and on receipt of the intimation from the applicant that all the staff members appointed in pursuance of the above statutes are in a position to start the teaching course, the University shall, after collecting such amounts as may be prescribed by the Executive Council from time to time from the applicant by means of a Demand Draft drawn in favour of the Registrar, University of Health Sciences, Vijayawada towards the affiliation fee for the second year B.Sc. Paramedical Course of study, it shall grant provisional affiliation for the second year B.Sc. course of study. It shall be competent for the University to withdraw the provisional affiliation granted herein by giving three months notice stating the reasons therefore to the applicant.
18. The provisional affiliation granted by the University as specified in statute 17 shall be only for the second year B.Sc. Paramedical Degree Course of study.
19. By the time six months period is left for the second year B.Sc. Paramedical Courses Degree examination the applicant shall apply to the University for affiliation of the third year B.Sc. Paramedical Courses of study in **Form-II Annexed** to these statutes. Before applying so, the following facilities and departments with the staff members stipulated in statute 20 have to be provided in the College of B.Sc. Paramedical Courses and the details thereof shall be furnished in the said application. The application for affiliation shall be accompanied by a Demand Draft Rs.25,000/- (Rupees twenty five thousand only) or such amount as may be prescribed by the Executive Council from time to time, drawn in favour of the Registrar, Dr. NTR University of Health Sciences, Vijayawada towards inspection fee.
20. On receipt of the application for affiliation for the third and Final year B.Sc. Paramedical Degree Courses from the applicant, the University shall send its Inspection Commission atleast three months before the date of commencement of the second year B.Sc. Paramedical Courses Degree Examinations.
21. The Inspection Commission sent by the University shall inspect the facilities available in the college and report to the University as to whether all the facilities required to be provided by the College are actually provided. The Inspection Commission shall also point out in its report the lacunae, if any, in the fulfillment of the conditions required to be fulfilled and also advise as to the capability of the college to rectify the lacunae within a period of two months. In case there are lacunae in the fulfillment of the conditions, the University may conduct re-inspection on payment by the applicant a sum of Rs.25,000/- (Rupees twenty five thousand only) or such amount as may be prescribed by the Executive Council from time to time by means of a Demand Draft drawn in favour of the Registrar, Dr. NTR University of Health Sciences, Vijayawada towards re-inspection fee and shall receive a final report from the Inspection Commission.
22. After a detailed examination of the final report of the Inspection Commission, if the University is fully satisfied as to the fulfillment of the conditions for the affiliation for the third year B.Sc. Paramedical Course of study and on receipt of the intimation from the applicant that all the staff members appointed in pursuance of the above statutes are in a position to start the teaching course, the University shall, after collecting such amount as may be prescribed by the Executive council from time to time, from the applicant by means of a demand draft drawn in favour of the Registrar, Dr. NTR University of Health Sciences towards the affiliation fee for the third and Final year B.Sc. Paramedical Course of study, it shall grant provisional affiliation for the third and final year B.Sc. Course of study. The University shall be competent to withdraw the provisional affiliation granted herein by giving three months notice stating the reasons therefore to the applicant.

23. The University shall be competent to inspect the college at least once in three years to ensure whether the quality of service, teaching and research are properly maintained.
24. The University shall also be competent to send observers during examinations at their discretion.
25. The applicant shall send to the University every year a report regarding the service academic and research activities of the college, and also annual staff return and vacancy position.
26. On the completion of the course of study by the first batch of students, the applicant may make an application to the University for the grant of permanent affiliation of B.Sc. Paramedical Course of Study in the prescribed **Form IV Annexed** with these Statutes, paying an inspection fee of Rs.25,000/- (Rupees twenty five thousand only). The University, after satisfying itself as to the performance of the college during the previous years and subject to the statutes and procedures in force from time to time, shall grant permanent affiliation to the B.Sc. Paramedical Courses Degree Course of Study.

It will be reed on verification, for every five years duly following the procedure prescribed above.

However, the management shall continue to pay affiliation fee to the University every year as prescribed by the Executive Council from time to time.

27. The Executive Council shall have the power after due enquiry to withdraw affiliation granted to a college, provided that before coming to such a decision, the Executive Council shall inform the Governing Body / Managing Committee of the college concerned of its findings after enquiry and shall allow it an opportunity of making such representation as it may deem fit and shall record its opinion on this representation so made.
28. It shall be competent for the University to send an Inspection Commission at any time to inspect the College of B.Sc. Paramedical Courses after two weeks notice to the applicant and on receipt of report from the Inspectors, the University may make any decision which in its opinion deems fit and necessary.
29. Affiliated institution shall apply to the University for starting of Postgraduate Courses only after three years of establishment of the institution / college and it has been granted permanent affiliation.
30. In case of the institution controlled by Government / Dr. NTR University of Health Sciences application of statute 9 (a) (b) (c) shall be decided by the Executive Council on the basis of merit. Government also shall sanction affiliation fee to be paid to the University.
31. The general statutes on affiliation which are not covered in this special statute on affiliation of colleges of B.Sc. Paramedical Courses shall be binding in addition to the above statutes.
32. If a medical college already established to conduct MBBS course and affiliated to Dr. NTR UHS, want to start B.Sc. Paramedical courses shall establish the following additional facilities.
